## GENERAL INSTRUCTIONS FOR COMPLETION AND SUBMISSION OF HYBRID ACTIVITIES

### 1.0 Cover Sheet

1.1 The professor has prepared a cover page for each of the 10 hybrid activities which comprise the hybrid activities course component of LAW2259. The cover pages are located in a folder entitled 'cover pages' (without the quotes) accessible via the hybrid activities button on Blackboard. Students are to locate the cover page which corresponds to this hybrid activity and fully complete that cover page via the computer in accordance with the instructions contained in this document and, where applicable, on the cover page itself.
2.0 Response Sheet(s)/Document(s)
2.1 There are two sets of response sheets for this hybrid activity, one set for Part A and another set for Part B. These responses sheets are located in the folder created for that hybrid activity. Hybrid activity folders are accessible via the hybrid activities button on Blackboard. Students are to fully complete response sheets for both parts of the hybrid activity in accordance with the instructions contained in the 'Instructions' document (without the quotes) and, where applicable, on the response sheets. Use point form responses.

### 3.0 Completion of Documents

3.1 All documents are to be completed on the computer using font type Times New Roman and font size 12 [unless otherwise specified].
3.2 Text contained in a document is to be left justified/aligned [unless otherwise specified].
3.3 Documents are to be printed on white paper which measures 8.5 inches in width and 11 inches in length using portrait format on one side of the page only [unless otherwise specified].
3.4 Documents are to be printed using black toner and the printing must be of sufficient quality that the document is legible as determined by the professor [unless otherwise specified].
3.5 Documents comprising the document package must not be defaced, i.e., contain 'whiteout', contain text which is scratched out, etcetera.

### 4.0 Submission

4.1 Staple the completed cover sheet which corresponds to this hybrid activity to the responses sheets by a single staple in the top left corner. This constitutes the document package.
4.2 Submit the document package by the due date.
4.3 Documents contained in the document package must appear in order, i.e., the cover sheet followed by the response sheets. As this activity consists of more than one part, the response sheets must be submitted in alphabetical order, i.e., Part A, Part B, etc.
4.4 Where there is more than one response sheet for a given part of the activity, the pages must appear in numerical order. [lf the pages are not numbered, the pages are to be organized by response number.]
4.5 Documents contained in the document package must be properly oriented, i.e., the print side of pages must face upward, the pages must not be upside down.
4.6 The document package (see definition above) submitted for a hybrid activity must not contain any additional documents. Do not use duo tangs, file folders, plastic covers, etc.
4.7 Students are responsible for retaining a copy of all course components submitted for this course.
